## Aunt Eileen's Yummy Thanksgiving Bread Stuffing

Here's a tasty family recipe for stuffing that's easy to prepare and a delicious addition to your Thanksgiving feast.

### Ingredients

- 2 lbs. bread (1 lb. white bread and 1 lb. whole wheat bread) toasted, soaked and squeezed dry
- 4 onions - chopped and sautéed
- 1 Tbsp. chopped parsley
- 1 cup celery cut fine
- 1/4 cup shortening
- 3 eggs
- 1 tsp. salt
- 1 tsp. paprika
- 1/2 tsp. pepper
- 1 cup corn flakes
- Optional (but really good if you can get them):
- 1 cup chopped chestnuts

### Directions

Mix all ingredients together. Place in a greased pan or cupcake pan. Bake in a 350° oven for approximately 45 minutes.



## On Our Minds: Bullying

The recent suicide of Jamey Rodemeyer shows just how hurtful and destructive bullying can be to its victims. It's important to know there are steps you can take to help your child and protect his or her legal rights.

1. **Talk to your child.** Let them know you are supportive and trustworthy.
2. **Put the school on notice.** Send a certified letter to the principal, the superintendent, the school board, and possibly the parents of the children doing the bullying.
3. **Keep accurate, detailed records** of each incident that occurs.
4. **Document any bruising or other injuries** with photographs and descriptions. Keep medical records.
5. **If your child is being cyberbullied, print out and save everything** that contains offensive comments, posts, pictures, or videos.
6. **Notify the police.** Some police departments have specialists who deal with computer and Internet investigations.
7. **Talk to the parents of the bullies as well as the teachers, the principal, the superintendent,** the guidance counselor and anyone else you believe can help. Take notes at these meetings.
8. **Is there a designated staff person trained for dealing with bullying?** The Dignity for All Students Act, which will go into effect July 1, 2012, requires schools to have at least one staff member trained to deal with bullying. Many schools are already beginning to comply by having staff members undergo training.

**Question:** I was injured in a restaurant, can I sue for my injuries?

**Answer:** There are several ways that you, as a customer or patron, can hold a business establishment responsible for your injuries. Sometimes a business creates a dangerous condition themselves—such as a waiter spilling a hot drink on you or dropping dishes on the floor that cause you to slip and hurt yourself. Other times a condition exists, such as a broken chair or loose floor tile, that was left unfixed for months. Usually witnesses can help provide support for these claims. However, if it just started raining and the floor is slippery because some people have come in with wet shoes, the place might not be held responsible. They were not

given enough warning to fix the problem. To sue a business, you need to prove they knew or should have known about the problem and they were negligent in taking care of it in a timely manner.
